

COMPANY POLICY - TRADE PRACTICE

PRICES: Pricing has been omitted from this catalog due to fluctuating conditions on materials. We are pleased to quote prices upon request.

TERMS: Indusco standard terms are **NET 30 DAYS**. Please refer to price schedules for cash terms or ask your sales representative. Unless otherwise stated, our quotations are for immediate acceptance. Clerical errors are subject to correction. Past due accounts are subject to a 1-½% per month service charge.

SHIPPING: Unless explicit instructions are given, we shall use our judgment to determine the most satisfactory routing of your order. All claims for damages, loss or delay must be made in writing to the carrier within 14 days, and notation made on delivery receipt.

ORDER CANCELLATIONS/RETURNS: Orders may not be cancelled without our written permission. Acceptance of cancellation will be based on particular merits of each case. If merchandise is to be returned for credit, we require written permission. If credit is allowed, merchandise is to be returned prepaid to Indusco less an applicable restocking charge. We cannot permit special order merchandise or cut material to be returned for credit.

LIMITED WARRANTY

Purchaser and INDUSCO expressly agree that INDUSCO'S warranty with respect to sale of its products is LIMITED solely to INDUSCO's choice of replacement or refund of the purchase price of any product or part thereof determined by INDUSCO to be defective within the first 90-day period following the transfer of the product from INDUSCO to the purchaser, providing that claims for any defects are made within the 90-day warranty period. Purchaser and INDUSCO expressly agree that remedies provided in this section are the purchaser's exclusive remedies in connection with the purchase or use of the product. Purchaser and INDUSCO expressly agree that in no event shall INDUSCO be liable for any incidental or consequential damages in connection with the purchase or use of the product. ALL OTHER WARRANTIES INCLUDING EXPRESS WARRANTIES AND THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE HEREBY DISCLAIMED. PURCHASER HEREBY WAIVES ALL OTHER WARRANTIES. RIGHTS AND REMEDIES ARISING BY LAW OR OTHERWISE INCLUDING, BUT NOT LIMITED TO, EXPRESS WARRANTIES, THE IMPLIED WARRANTY OF MERCHANTABILITY, ANY IMPLIED WARRANTIES ARISING FROM COURSE OF PERFORMANCE, COURSE OF DEALING OR USAGE OF TRADE AND IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. ADDITIONALLY, INDUSCO HEREBY DISCLAIMS ANY OF ITS OBLIGATIONS OR LIABILITIES ARISING FROM STATUTE, WARRANTY, CONTRACT, TORT OR NEGLIGENCE. This warranty between purchaser and INDUSCO is complete. All prior or contemporaneous discussions, representations, agreements and/or understandings are merged into and are superseded by this warranty. Any dispute about the interpretation of this warranty shall be governed by the laws of the State of Maryland.
